The State of Texas }  
 County Tarrant } Thomas, by Deed of Trust dated on the 20<sup>th</sup>  
 day of August A.D. 1888, and recorded in the County Clerk's office  
 of Aransas County Texas, in Volume A page 549, Samuel H.  
 Smith and Clara Smith conveyed to C. H. Gilliman, Trustee, 7457  
 acres of land fully described in said Deed of Trust, to which ref-  
 erence is hereby made for a more particular description, for the  
 purpose of securing Land Mortgage Bond of Texas Limited, in the  
 payment of one certain promissory note for the sum of Fifty  
 Thousand Dollars, and Thomas Aransas Pass Colonization  
 Co has paid Two hundred Dollars, in cash as a credit on  
 said note on account of interest past due.

Now Therefore, I, C. H. Gilliman, Trustee, as aforesaid,  
 and agent and attorney in fact for the Land Mortgage  
 Bond of Texas, Limited, the legal owner and holder of  
 said note do hereby release 15 acres Beginning at the S.E. corner  
 of 22 1/2 acres heretofore sold to A. Seidel and N.W. Cor. of Block No 20  
 Braett Bros, Thence S 70 E, 22 1/2 yrs to a stake in that line of  
 160 acres conveyed to Eugene Williams, Thence North 75 3/2 yrs to  
 a stake Thence N. 70 W 8 1/2 yrs to N.E. Cor Seidel's 22 1/2 acres. Thence  
 S 20 W 712.5 yrs to beginning, from the incumbrance created by

said Deed of Trust; but it is understood that the lien created by said Deed of Trust is retained on the balance of the 7457 acres not hereby specially released.
